## I. CALL TO ORDER

Mayor Pulice called the meeting to order at 6:32 p.m.

## III. BUSINESS ITEM

A. Approval of Minutes – October 20, 2021 Motion by Commissioner Sbertoli to approve the October 20, 2021 Minutes. Second by Alderman Woods. Motion carried.

## IV. REPORT AND RECOMMENDATION:

A. White Oaks Park Project

Mr. Appler reported that the Park District hosted another community workday on November 6 where volunteers helped remove buckthorn from White Oaks Park. Mr. Appler also reported that per the City's Planned Unit Development requirements, the Park District had a wetland buffer monitoring report prepared in 2021 and all standards were met for the first year.

#### B. Park District Property

Mr. Ellmann reported that the Mohawk Manor Park annexation is in motion. Also, Mr. Ellmann informed the Committee that Hitchcock Design Group had prepared a Yield Study and two conceptual plans for Terrace Park, a park that is in the Village of Bensenville, but also in the Wood Dale Park District. The Park District Board of Commissioners reviewed the concept plans at its last meeting.



## C. Joint Special Events

Ms. Buggy reported that planning is well under way for the Memorial Day Parade which will be held on Monday, May 30. Grant Paplauskas left the City in February for a position at another municipality, so Janelle Silva has been promoted to Communications and Special Events Manager.

## D. Wayfinding Signs

Ms. Buggy reported that staff is working on a plan for signs in the community. In addition to a sign at Community Square, staff is working on additional wayfinding signs for the community and temporary event signs to post at the entrances of the City. Landmark is preparing a cost estimate for the Community Square sign.

#### E. Citizen Involvement Committee

Mayor Pulice reported that the Citizens Initiative Committee had several comments about the Park District at its last meeting. Participating residents noted that they don't feel their needs are being heard by the Park District. Additionally, participating residents suggested that the Park District should host more family-friendly events, like an outing to a Chicago Dawgs game at Rosemont or a hockey game at Allstate. Mr. Ellmann stated that the Park District does regularly provide trips like this, but it's primarily seniors who sign up. In addition, thanks to rising interest, the Park District has made pickleball available but there has been low resident participation. Alderman Woods suggested that if citizens reach out to their neighbors in addition to regular texts and emails, interest in Park District offerings may increase. Mayor Pulice offered to play a short video on pickleball at the next Citizens Initiative Committee.

#### 2. Movie Projector
