AN ORDINANCE ANNEXING PROPERTY BEARING THE CURRENT COMMON ADDRESS "6N204 ASH STREET" TO THE CITY OF WOOD DALE, ILLINOIS 60191

WHEREAS, Edyta Ostas (hereinafter "Petitioner") is the owner of a certain property located at the current common address of 6N204 Ash Street, in unincorporated DuPage County, as legally described as follows:

LOT 11 IN BLOCK 9 IN WOODDALE HIGH VIEWS, BEING A SUBDIVISION OF PART OF THE SOUTHEAST QUARTER OF SECTION 10, TOWNSHIP 40 NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JULY 11, 1994 AS DOCUMENT 464774, IN DUPAGE COUNTY ILLINOIS.

("Subject Realty"); and

WHEREAS, a written petition, signed by Petitioner, a copy of which is attached hereto as Exhibit "A," has been filed with the City Clerk of the City of Wood Dale, DuPage County, Illinois, requesting that the Subject Realty be annexed to the City of Wood Dale; and

WHEREAS, the Subject Realty is not within the corporate limits of any municipality but is contiguous to the City of Wood Dale; and

WHEREAS, the Subject Realty is and will continue to be served by the Wood Dale Fire Protection District, and is currently not a part of any Public Library District; and

WHEREAS, the Subject Realty does not include or abutt any highway right of way under the jurisdiction of any Township; and

WHEREAS, notice of said annexation has been given or will be given to public bodies required to receive such notice pursuant to statute; and

WHEREAS, all petitions, documents, and other necessary legal requirements are in full compliance with the statutes of the State of Illinois, specifically sections 7-1-1 and 7-1-8 of the Illinois Municipal Code; and

WHEREAS, it is in the best interests of the City of Wood Dale that the territory be annexed thereto.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DUPAGE COUNTY, ILLINOIS:

SECTION ONE: That the following described territory:

LOT 11 IN BLOCK 9 IN WOODDALE HIGH VIEWS, BEING A SUBDIVISION OF PART OF THE SOUTHEAST QUARTER OF SECTION 10, TOWNSHIP 40 NORTH, RANGE 11, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JULY 11, 1994 AS DOCUMENT 464774, IN DUPAGE COUNTY ILLINOIS.

Common Address: 6N204 Ash Street, Wood Dale, Illinois 60191,

Being indicated on the plat of annexation, as appended to and a part of this Ordinance as Exhibit "B," is hereby annexed to the City of Wood Dale, DuPage County, Illinois, and shall after annexation be known by the common address 420 North Ash Avenue, Wood Dale, Illinois 60191.

SECTION TWO: That the official map of the City of Wood Dale be amended to reflect the extension of corporate limits of the City of Wood Dale to include the Subject Realty hereinabove described and to the far side of the adjacent roadway, and annexed hereby.

SECTION THREE: That the City Clerk of the City of Wood Dale is directed hereto to file in the Office of the County Clerk, DuPage County, Illinois, a certified copy of this Ordinance, together with an accurate Plat of Annexation of the Subject Realty, to record in the Office of the Recorder, DuPage County, Illinois, a certified copy of this Ordinance, together with an accurate Plat of Annexation of the Subject Realty, and to provide notice of this annexation to the DuPage County Clerk, Election Division, and to the United States Postal Service.

SECTION FOUR: That the City Clerk of the City of Wood Dale be and is hereby directed to publish this Ordinance in pamphlet form, pursuant to the Statutes of the State of Illinois, made and published.

SECTION FIVE: That all ordinances or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

SECTION SIX: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in the manner provided by law.




