REPORT & RECOMMENDATION

CLARIFY APPLICABILITY OF CITY SERVICES INCENTIVE PROGRAM POLICY

DISCUSSION:

Director Springer stated that Staff is inquiring if the Committee would like to allow commercial uses and multiple principal structures on a single property to take advantage of the City Services Incentive Program when connecting to utilities.

At the end of March 2023, a letter was sent out to 170 residents in the City, explaining the Incentives Program Policy to incorporated residents that are not yet connected to City water service. The Mayor inquired if they are all annexed in? Director Springer stated no some are unincorporated. In response to the mailing, several property owners have reached out to City staff to inquire about connection to City utilities. One of the owners that contacted the City has two principal structures on a single commercial lot. One of the principal structures is a home and the second is a business. As the Policy is currently written, only residential properties are allowed to participate in the incentive program and only one reimbursement can be approved per property. Therefore, based on the language in the Policy, we could allow the incentive for connecting the home on the above referenced property, but not for the commercial building that is on the same lot.

So, the question is do you want us to open up the program to commercial properties, and offer it to customers who have more than one structure on the property.

Alderman Woods stated that being one of the members of the CDC at the time that this was written the original concept was to offer to everyone the availability for water hookup with the City. We took into consideration unincorporated houses and did not think about commercial hookups since there was such a small number. So now that the issue has come up what we need to do is to clean up the language to entertain the intent for the inclusion of commercial buildings and customers with more than one structure on their property. The Mayor asked if you have 2 structures would you run them off one b-box, or would you need 2? Director Lange stated that each service would need their own separate b-box connection.

The Mayor inquired about how we would handle an instance like when we had 2 inches of rain, and it flooded his back room which he knew that it would be gone in 2 hours. So, in that circumstance would I qualify for the program? Director Lange answered yes. If there is any kind of flooding or draining issue on your property that you want to fix you would qualify. But if it is not an ongoing flooding problem you would probably not want to spend the money to fix it. And if you apply you would have to follow the instructions such as: fill out the application, have photos of the water flooding, a drawing of the flooding area, and 3 price quotes. The work is also given a recommendation by an engineer who evaluates each situation separately.
