APPROVAL OF MINUTES:

Ald. Catalano made a motion, seconded by Ald. Ames, to approve the minutes of the March 23, 2023 meeting as presented. A voice vote was taken, with all members voting aye.

REPORT & RECOMMENDATION

LOT CONSOLIDATION AT 470 ARBOR LN

DISCUSSION:

Director Springer started by explaining that this is a lot consolidation request by the owner Nicole Judas. She would like to combine a 50 ft lot that is currently vacant with a remanent 16 ft lot, which is immediately adjacent and undeveloped into a single lot which is 66 ft in order to create a conforming lot. This is because the code states that the minimum lot width is 65 feet. She purchased the 50-foot lot in September of 2022, and then bought the adjacent 16 feet from her father in February 2023. She has already put in for a building permit, but obviously we cannot issue a permit until the plat of consolidation is approved.

Alderman Messina asked if she could give more information about the lot because he knew that there was some history behind it. Director Springer began by stating that in 2005 her father had purchased a larger tract of land and it was annexed into the city, and then subdivided the property into several lots in 2008. At that time, he wanted to buy the 50-foot lot, but the property owner wasn't inclined at that time to do so. So, he bought the 85-foot lot and the 16-foot lot, he only needed the 85 feet to conform so there always was the leftover 16 feet. The property became available, and the daughter purchased the 50-foot lot and now would like to combine the lots so they can build a home.

It showed that there was previously and island that separated exiting and entering traffic. This configuration seemed to slow down the through traffic. After the construction of 83 it was removed and now there is no barriers. He also stated that if needed he has petitions signed and notarized by every resident in the subdivision. Also, he stated that he went to several surrounding communities to observe what projects they undertook to close off the residential streets to route 83 and route 53 traffic.
