



A RESOLUTION APPROVING A PROPOSAL FROM PERFORMANCE PIPELING, INC. FOR THE GILBERT DRIVE SANITARY SEWER REPAIR IN AN AMOUNT NOT TO EXCEED \$74,420.36

WHEREAS, the City of Wood Dale (hereinafter referred to as the "City") is a duly organized and existing body politic and corporate governed by the provisions of the Illinois Municipal Code, 65 ILCS 5/1-1-1, *et seq.*, and its own duly adopted Municipal Code; and

WHEREAS, the City is authorized and empowered under the Illinois Municipal Code, and its Ordinances adopted pursuant thereto, to enter into agreements and to contract for goods and services; and

WHEREAS, the Mayor and the City Council of the City seek to ensure that the City is run effectively and efficiently; and

WHEREAS, the Mayor and the City Council of the City, seeks **PERFORMANCE PIPELING, INC.** for the **GILBERT DRIVE SANITARY SEWER REPAIR**; and

- Price includes advanced warning signs and cones.
- Professional traffic control and flaggers are not included and is not anticipated.
- Bypass pumping up to a 3" bypass pump is included. Bypass conditions beyond 3" capabilities are not included.
- Standard Insurance coverage included, see attached.
- Pricing is valid for 30 days.
- Pricing is based on standard M-F 7am-7pm construction schedules.
- Price does not include any additional costs associated with permitting or bonding.
- Price includes Post Televising of repair.
- Price includes all PVC pipe and fittings to complete repair per project specifications.
- Price includes replacing and tying back in of service laterals up to 5'. Lateral replacement beyond 5' would be an additional cost of \$150/LF.
- Price includes stone base with 24" of pipe coverage and trench backfill.
- Price includes spoils removal, but excludes fees associated with testing if applicable.
- Price includes grass restoration with topsoil, grass seed, straw matting.
- Price includes concrete drive/sidewalk removal and replacement as necessary for repair.
- Price DOES NOT include removal and stump grinding of 6 trees. To be provided by others prior to repair.
- Pricing is based on standard excavation conditions; running sand and or unstable ground causing excessive over-digging / undermining is not included.
