### **DISCUSSION:**

Alderman Woods asked about the selection process, as I look through this why would we not go with Robinson Engineering and save the money? The RP Steering Committee when these were reviewed Robinson Engineering didn't submit any funds for additional authorized services as directed, and there was some discussion that might disqualify them, and they did not submit a complete proposal. If you take out the missing items from the other proposals the prices would be comparable. Alderman Woods asked if he could go over some of the items that they did not include that disqualified them? Director Lange stated that they specifically excluded some things that the other Consultants included like topographical surveys or geotechnical work. There was one item that they did not include and that was updating the hydraulic modeling and looking at alternative sites. The mayor stated that since we started the RFP this is probably the third time that somebody didn't complete the packet, so if they couldn't follow the directions we shot them down regardless if they were cheaper or lower. But in the Robinsons bid document that we don't feel at this time it is necessary, but if it then we can always talk about it. To me that is someone playing games and trying to skirt the system. Director Lange stated that HR Green completed the Water Distribution Master Plan so they had already done some modeling including modeling for alternate locations and it was agreed that it would be needed be included in the proposal.
