# CITY OF WOOD DALE FY 2025 RAT MITIGATION PROGRAM

#### **CONTRACT**

This CONTRACT, made and entered into this 16<sup>th</sup> day of May, 2024, by and between the CITY OF WOOD DALE, an Illinois municipal corporation (hereinafter "City"), and CHEM-WISE ECOLOGICAL PEST MANAGEMENT, an Illinois corporation (hereinafter "Contractor");

#### RECITALS

WHEREAS, the City desires to engage the Contractor to provide services (hereinafter "Work"), located within the corporate limits of the City of Wood Dale; and

WHEREAS, the Contractor represents itself to be in compliance with Illinois Statutes relating to all matters affecting its status as a corporation operating as a general contractor within the State of Illinois and to have the necessary expertise and experience to furnish such services for the Work upon the terms and conditions set forth herein below:

NOW, THEREFORE, in consideration of the mutual promises herein contained, it is hereby agreed by and between the City and the Contractor that:

# I. SCOPE OF SERVICES

The Scope of Services shall be as set forth in the "Request for Proposals" prepared by the City. Should there be a conflict in terms between this Contract and the other documents, which are a component part hereof, this Document shall control.

# II. PERFORMANCE OF WORK

The Contractor shall perform all work, furnishing all materials and labor, and shall abide by the terms of this Contract and the requirements of the City.

# III. TERM

This contract shall take effect upon the date of approval by the City Council and continue for a term of one (1) year.

#### IV. RENEWAL

At the end of the one (1) year term, and each subsequent term thereafter, and by mutual agreement of the parties, this contract may be extended for an additional one (1) year term. Prior to each term expiring, the Contractor shall submit updated pricing for the

Work for acceptance by the City. The City reserves the right to request other proposals from qualified contractors or to request a change in the scope of work for which the Contractor may alter their pricing. Should the Contractor no longer be able to provide the requested services for subsequent terms, the Contractor shall notify the City in writing prior to expiration of the Contract.

#### V. PAYMENT TO THE CONTRACTOR

For the Work, the Contractor shall be paid in accordance with the Proposal. The City shall make payments to the Contractor within 30 days after completion of the Work and upon receipt of an invoice in a format approved by the City.

This contract calls for the construction of a "public work," within the meaning of the Illinois Prevailing Wage Act, 820 ILCS 130/.01 et seq. ("the Act"). The Act requires contractors and subcontractors to pay laborers, workers and mechanics performing services on public works projects no less than the current "prevailing rate of wages" (hourly cash wages plus amount for fringe benefits) in the county where the work is performed. The Department publishes the prevailing wage rates on its website at <a href="http://labor.illinois.gov/">http://labor.illinois.gov/</a>. The Department revises the prevailing wage rates and the contractor/subcontractor has an obligation to check the Department's web site for revisions to prevailing wage rates. For information regarding current prevailing wage rates, please refer to the Illinois Department of Labor's website. All contractors and subcontractors rendering services under this contract must comply with all requirements of the Act, including but not limited to, all wage requirements and notice and record keeping duties.

# VI. NO CO-PARTNERSHIP OR AGENCY

It is understood that nothing herein contained is intended or shall be construed to, in any respect, create or establish the relationship of co-partners between the City and the Contractor, or as constituting the Contractor as the general representative or general agent for the City for any purpose whatsoever.

# VII. CONTRACT DOCUMENTS

It is further understood that this Contract consists of the following documents which are hereby made a part hereof: the City's Request for Proposals, the Contractor's Proposal, Performance Bond, Maintenance Bond, Anti-Collusion Affidavit of Compliance, Americans with Disabilities Act of 1990 Certificate, Policy Against Sexual Harassment Certificate, Hold Harmless Agreement, Anti-bid Rigging Certificate, and Drug-free Workplace Certificate.

#### VIII. SEVERABILITY

The parties intend and agree that, if any paragraph, subparagraph, phrase, clause, or other provision of this Contract, or any portion thereof, shall be held to be void

or otherwise unenforceable, all other portions of this Contract shall remain in full force and effect.

#### IX. HEADINGS

The headings of the several paragraphs of this Contract are inserted only as a matter of convenience and for reference and in no way are they intended to define, limit, or describe the scope or intent of any provision of this Contract, nor shall they be construed to affect in any manner the terms and provisions hereof or the interpretation or construction thereof.

#### X. MODIFICATION OR AMENDMENT

This Contract constitutes the entire contract of the parties on the subject matter hereof and may not be changed, modified, discharged, or extended except by written amendment duly executed by the parties. Each party agrees that no representations or warranties shall be binding upon the other party unless expressed in writing herein or in a duly executed amendment hereof, or Change Order as herein provided.

#### XX. APPLICABLE LAW

This Contract shall be deemed to have been made in, and shall be construed in accordance with the laws of the 18<sup>th</sup> Judicial Circuit Court of DuPage County, State of Illinois.

#### XXI. NEWS RELEASES

The Contractor may not issue any news releases without prior approval from the City Manager nor will the Contractor make public proposals developed under this Contract without prior written approval from the City Manager prior to said documentation becoming a matter of public record.

#### XXII. COOPERATION WITH OTHER CONTRACTORS

The Contractor shall cooperate with any other Contractors in the City's employ or any matter associated with the Work.

# XXIII. NOTICES

All notices, reports and documents required under this Contract shall be in writing and shall be mailed by first class mail, postage prepaid, addressed as follows:

# **Pest Mitigation Information**

Mitigation efforts regarding rodent issue in targeted areas in Wood Dale.

#### Initial Service - Phase 1

Chem-Wise proposes initial services of the following problem areas:

<u>Central Ave, Catalpa Ave, Oak Ave, Elmwood Ave, and Walnut Ave, and Maple Ave,</u> Installation of four weighted rodent stations along the alley near the fenced areas; these stations would be monitored monthly, with appropriate follow-up.

#### Cedar Ave

Place exterior stations and work with business owners regarding their pest control program.

#### **Division St**

Installation of four to eight bait stations in public areas, monitor monthly and follow-up appropriately.

The following actions are recommended:

#### **Local Business Owners**

- Clean up all garbage adjacent to business.
- Secure dumpster lids to prevent access.
- Take measures to exclude rodents from the property.
  - Installing door sweeps.
  - o Sealing/repairing any cracks or gaps in the building's exterior.
  - Having a regular pest control program for both interior and exterior of the business.

#### City of Wood Dale

- Assist in cleaning the alleyway behind the businesses.
- Take measures to control weed growth and general overgrowth.
- Set up ongoing monitoring services with a pest control company for impacted areas.
- Help increase residential and commercial awareness in nearby areas on how to prevent rodent based issues.

# Pest Control Company

- Install rodent bait stations around the impacted areas.
- Inspect all areas for burrows and other potential sources of rodents.
- Regularly monitor all bait stations and other activity sources.

The initial investment for Phase 1 is approximately \$1,200 with a monthly maintenance cost of \$300.

# Cost-Share Program - Phase 2

To assist with rodent mitigation city-wide, the City can enter into an agreement with Chem-Wise Pest Management for a cost-share program.

In the event a resident/business is experiencing an issue with rodents, the City can offer the following program:

Initial inspection and treatment of the property with the installation of one exterior station. The treatment plan would include two months of follow-up services as needed.

Cost to Resident/Business: \$70

Cost to City: \$70

An application and general requirements will need to be created. The <u>Village of Skokie's rat control program</u> is comprehensive and provides a template that can be modified for the City of Wood Dale.
