



**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF
THE CITY OF WOOD DALE CHAPTER 3, ARTICLE VII TO COMBINE WOOD
DALE FOR A GREENER TOMORROW COMMISSION AND THE STORMWATER
MANAGEMENT COMMITTEE INTO A NEW ENVIRONMENTAL AND
SUSTAINABILITY COMMITTEE AND AMENDING CHAPTER 3, ARTICLE I,
SECTION 3.106(B) TO REMOVE REFERENCES TO
WOOD DALE FOR A GREENER TOMORROW COMMISSION
AND THE STORMWATER MANAGEMENT COMMITTEE**

WHEREAS, the City of Wood Dale (hereinafter referred to as the “City”) is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

WHEREAS, the City possesses the authority, pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*, to adopt ordinances pertaining to the public health, safety, and welfare; and

WHEREAS, the City Council of the City (hereinafter referred to as the “City Council”) is the corporate authority for the City and is authorized by law to exercise all powers and to control the affairs of the City; and

WHEREAS, the City Council possesses full power and authority to approve and pass all necessary ordinances, resolutions, rules and regulations necessary for carrying into effect the objects for which the City was formed, in accordance with the Illinois Municipal Code; and

WHEREAS, the City Code authorizes and establishes several boards, commissions and advisory subcommittees; and

WHEREAS, the City Commission known as Wood Dale for a Greener Tomorrow and the City Advisory Subcommittee known as the Stormwater Management Committee address similar environmental interests, issues, and concerns; and

WHEREAS, combining the Wood Dale for a Greener Tomorrow Commission with the Stormwater Management Committee will provide for a more comprehensive, consistent, and streamlined approach to stormwater, environmental, and sustainability issues; and

WHEREAS, the City Council finds that it is in the best interests of its residents to combine the Commission known as Wood Dale for a Greener Tomorrow with the Advisory Subcommittee known as the Stormwater Management Committee.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Wood Dale, DuPage County, Illinois, as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: Article VII (Wood Dale For A Greener Tomorrow) of Chapter 3 (Boards and Commissions) is hereby repealed and rescinded in its entirety and replaced with a new Article VII which shall read as follows:

ARTICLE VII

ENVIRONMENTAL AND SUSTAINABILITY COMMITTEE

Sec. 3.701. Committee Created.

There is hereby created a Committee known as the Environmental and Sustainability Committee.

Sec. 3.702. Membership.

- A. The Environmental and Sustainability Committee shall consist of six (6) members. At least one member shall be an Alderman from the City Council.
- B. In making the original appointments under this Section, the City Council shall designate members to serve for a three (3) year term; members to serve for a two (2) year term; and a member to serve for a one (1) year term. Thereafter, appointment shall be made for a full three (3) year term.

Sec. 3.703. Powers and Duties.

The Environmental and Sustainability Committee shall have the following duties:

- A. To protect, sustain, and improve a clean and healthful environment to benefit present and future generations.
- B. To make recommendations to the City Council concerning the alleviation of stormwater drainage and sanitary sewer matters within the corporate limits of the City.
- C. To serve as an Advisory Body to the City Council to provide valuable citizen input.
- D. Such other and further duties as may be requested by the City Council or City Manager.

Sec. 3.704. Meeting Schedule.

Regular meetings of the Environmental and Sustainability Committee will typically be held on the first Wednesday of the months of January, April, July, and October, or as needed in accordance with section 3.105 of this chapter.

SECTION THREE: Chapter 3, Article 1, Section 3.106(B), of the Municipal Code of the City of Wood Dale of 1993, as amended, is hereby amended by adding the underlined language and deleting the stricken language as follows:

Sec. 3.106. Appointment Of Members To Boards and Commissions.

B. Members of the following boards and commissions shall be appointed, and the Chairperson designated annually, by the Mayor, subject to confirmation by the City Council:

1. Board of Fire and Police Commissioners.
2. Building Code Board of Appeals.
3. Community Development Commission.
4. Citizen Involvement Committee.
5. Streetscape and Economic Enhancement Committee.
6. ~~Wood Dale for a Greener Tomorrow Committee.~~ Environmental and Sustainability Committee.
7. ~~Wood Dale for a Greener Tomorrow Stormwater Subcommittee.~~

SECTION FOUR: All other ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance, are, to the extent of such conflict, expressly repealed.

SECTION FIVE: That the City Clerk of the City of Wood Dale be and is directed hereby to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

SECTION SIX: That this Ordinance shall be in full force and effect after its passage, approval, and publication in the manner provided by law.
