### **II. ROLL CALL**

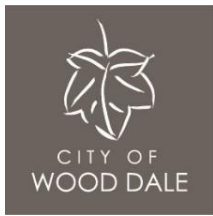

### **III. BUSINESS ITEM**

A. Approval of Minutes – May 8, 2018  
Motion by Alderman Jakab to approve the May 8, 2018 Minutes. Second by  
Mayor Pulice. Motion carried.

### **IV. REPORT AND RECOMMENDATION:**

- A. Status Update on White Oaks Park Project  
Mr. Ellmann provided a brief update on the White Oaks Park project. Mr. Ellmann reported that the Park District Board of Commissioners held a special meeting approximately two weeks ago with residents to discuss the direction of the project and resident concerns. A working group meeting with residents will also be held on June 26.
- B. Discussion of Mittel Drive Extension Project and Next Steps  
Mr. Krall and Mr. Marquardt provided a presentation on a draft timeline of next steps for the Mittel Drive Extension project. Per the timeline, once the Park District and School District boards identify their priorities, the three bodies would hold a workshop to discuss the priorities and identify potential alternatives to make each group whole. The three bodies would also host public outreach to seek input and ideas from residents as well as acceptance of the project. The Committee members expressed support for the timeline. Commissioner

Stimpson stated that the Park District Board of Commissioners should have an approved list of priorities by July or August so the initial workshop could be held in August or September. Alderman Woods asked staff to set up a meeting with HR Green and the School District Board of Directors as soon as possible to relay this information and ensure the three bodies are working in conjunction with each other. Staff will contact the School District Superintendent to arrange the meeting.

C. Update on Joint Special Events

Mr. Ellmann reported that the first summer movie is being held tonight in the facility's gym. Two additional movies will be held in September on the green space area between the pool and police department; the movies will be Black Panther on September 14 and Jurassic World on September 21. Ms. Buggy reported that staff has begun discussions to have the Park District play a larger role in the annual tree lighting celebration on December 2, which will include crafts for kids, a kids' dash, Santa visit, and improved sound system. The 2019 event may be expanded to include a 5k run that ends at City Hall at the beginning of the Tree Lighting festival.

Alderman Jakab inquired as to why the cost for the movies at the pool is \$4 per resident. Mr. Ellmann explained that the Park District had already planned the two movies at the pool before the City and Park District agreed to work together on the events; contributing to the amount are the costs for keeping the pool open and staffing the events with lifeguards. Mr. Ellmann stated that the Park District could look at ways to eliminate the costs for the movie series next year.
