CALL TO ORDER:

Alderman Art Woods called the meeting to order at 6:32 pm. Roll call was taken and a quorum was present.

APPROVAL OF THE MINUTES:

Steve Mikos motioned to approve the minutes of the July 1, 2019 meeting, seconded by Michael Curiale. The minutes were unanimously approved via voice vote.

NEW BUSINESS:

A. Wind Sculptures

Ms. Gosia Pociecha presented an overview of the existing sculptures, their condition and proposed locations. The City is in possession of nine (9) wind sculptures which used to be located in Dunklee's Park and were removed before construction of the clock tower. The wind sculptures are currently located in the Public Works building. Some have sustained minor damage, but the Public Works Assistant Director has requested a quote from the distributor for repair and installation. The Committee discussed the probable new locations for the wind sculptures. Consensus was that they should be located in a visible, well-lit area to avoid potential for vandalism; the Committee was also receptive to separating the sculptures and install them in multiple locations. The possible locations that were identified included: Metra commuter lot, Dunklee's Triangle, City Hall, detention pond directly to the north of the Library, pedestrian bridge over Irving park Road, detention ponds by Elizabeth Court. With the Streetscape Committee's direction, the City staff will perform site visits to evaluate which locations could accommodate installation of the sculptures and will report back during future meeting.

OTHER BUSINESS:

A. Request for future agenda items

Future agenda items to include a list of projects considered by the Streetscape Committee showing their status. Other requests included update on the street banners, Veteran's Memorial, solar lights for monument signs and update on the Façade Improvement Program.

ADJOURNMENT:

A motion to adjourn was made by Alderman Woods, seconded by Michael Curiale, and carried unanimously by voice vote. The meeting adjourned at 7:29 pm.

SUBJECT: Wind Sculptures – review of probable locations

OVERVIEW

The Streetscape & Economic Enhancement Committee discussed the wind sculptures during the September 9, 2019 meeting. At that time few possible locations were identified where the sculptures could be re-installed. Staff has prepared a brief overview of the probable locations.

BACKGROUND

The City is in possession of nine (9) wind sculptures that used to be located in Dunklee's Park near the intersection of Irving Park and Wood Dale Roads (see exhibit A for photos of the available wind sculptures). The wind structures are currently located in the Public Works building. It has been noted that some of them may have sustained damage during deconstruction and/or storage, but the Public Works director reported that the damage is very minor. He also reported that he is still waiting for a quote from the distributor to repair and re-install the sculptures.

During the last Committee meeting a number of possible locations for re-installation of the sculptures were identified. There was consensus that the sculptures may be separated and installed in multiple locations, but also it was emphasized that these should be visible well-lit locations, to avoid possibility of vandalism. Below is an overview list and the aerial photographs & photos are attached in Exhibit B.

Location		Notes
1.a.	Wood Dale Metra Station	Not owned by the City, but it may be possible to request a permission from property owner. Could accommodate multiple sculptures in 3 locations. Good visibility from the train, also locations 1.b and 1.c have good visibility from Irving Park Rd.
1.b.	Wood Dale Metra Station	
1.c.	Wood Dale Metra Station	
1.d.	Wood Dale Metra Station	Owned by the City, however is less visible.

2	Dunklee's Triangle	Not owned by the City, may require IDOT ROW permit. Limited space, but could accommodate 1-2 sculptures in the grass area.
3	Clock Tower	Owned by the City. Limited space, but could accommodate 1-2 sculptures in the grass area.
4	Wood Dale City Hall	Owned by the City. Limited visibility due to mature landscaping, but could accommodate 1-2 sculptures in the grass area by the entrance.
5	Dentation Pond (Wood Dale Rd & School St)	A multi-purpose path will be installed at this site in the near future (part of the re-development of the two parcels to the north). Once the path plans are finalized, staff will review to see if any sculptures could be incorporated. May be limited by the overhead wires and mature landscaping.
6	Pedestrian Bridge	Owned by ComEd. Not recommended due to limited space and overhead wires.
7	Addison Rd Detention Basin	Owned by the City, used for stormwater management. Not recommended due to limited space in the ROW, overhead wires and mature landscaping.
8	Addison Rd & Gilbert Dr	The parcel at south-west corner of Addison Rd & Gilbert Dr is owned by the City, used for stormwater management. Less visible site, overhead wires along the property line.
9	Salt Creek Forest Preserve	Owned by the Forest Preserve District. Entrance to the Salk Creek Forest Preserve, not incorporated into the City of Wood Dale.
10	Elizabeth Ct & Wood Dale Rd	Owned by the City, used for stormwater management. Two parcels NE and SE corners, could accommodate sculptures near the intersection of roads.

The Streetscape Committee may wish to discuss these probable locations and narrow down the locations that would be most ideal.

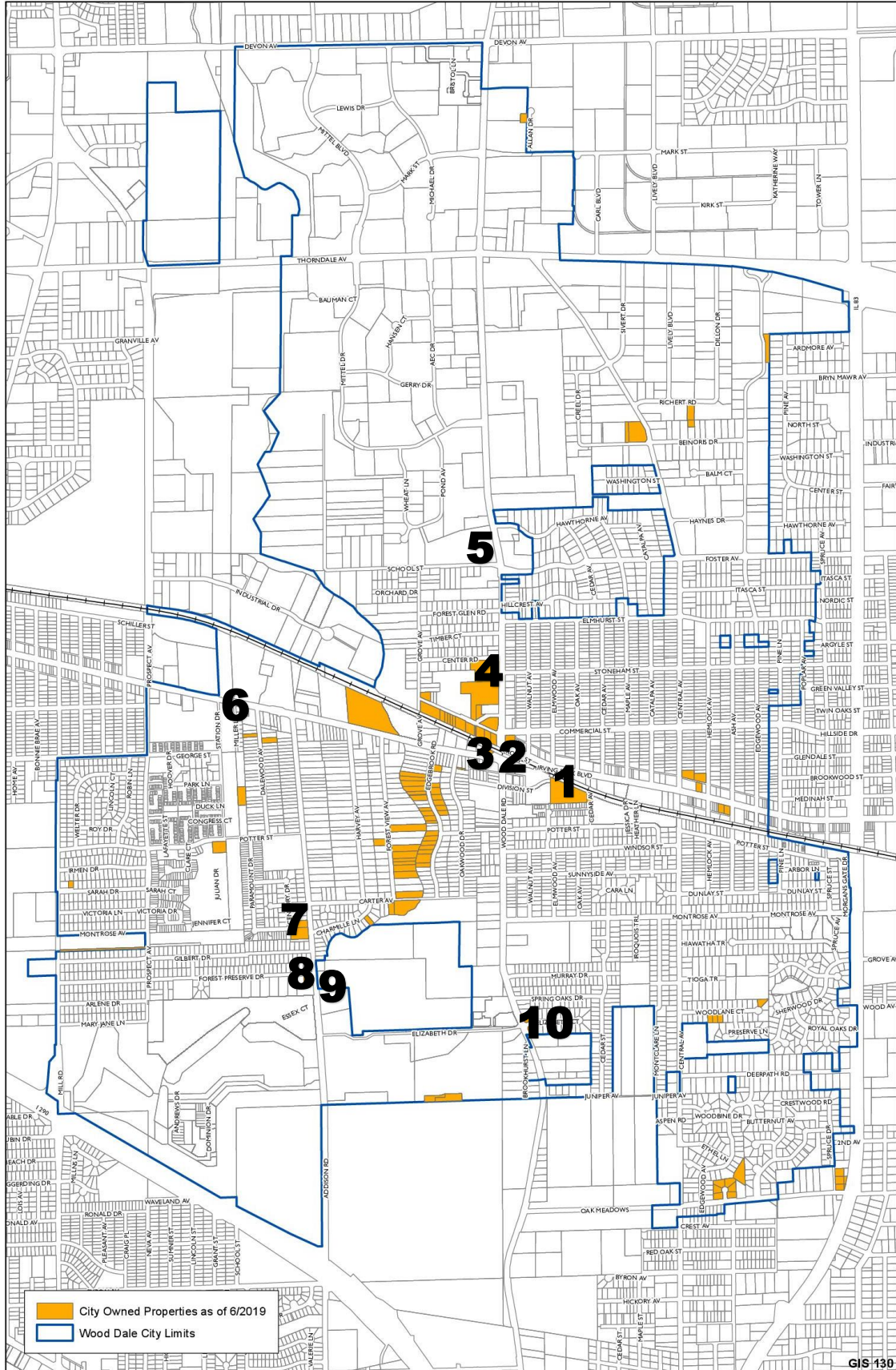

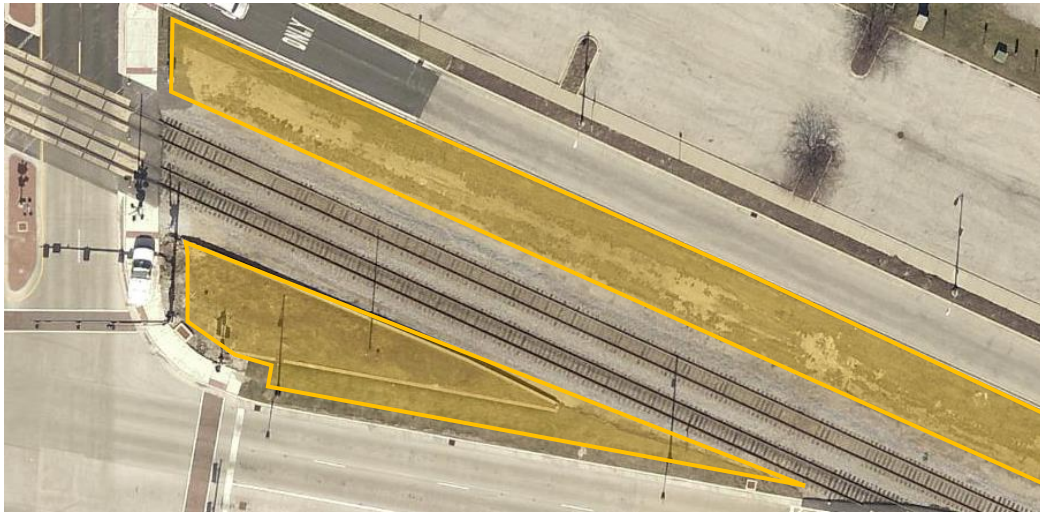

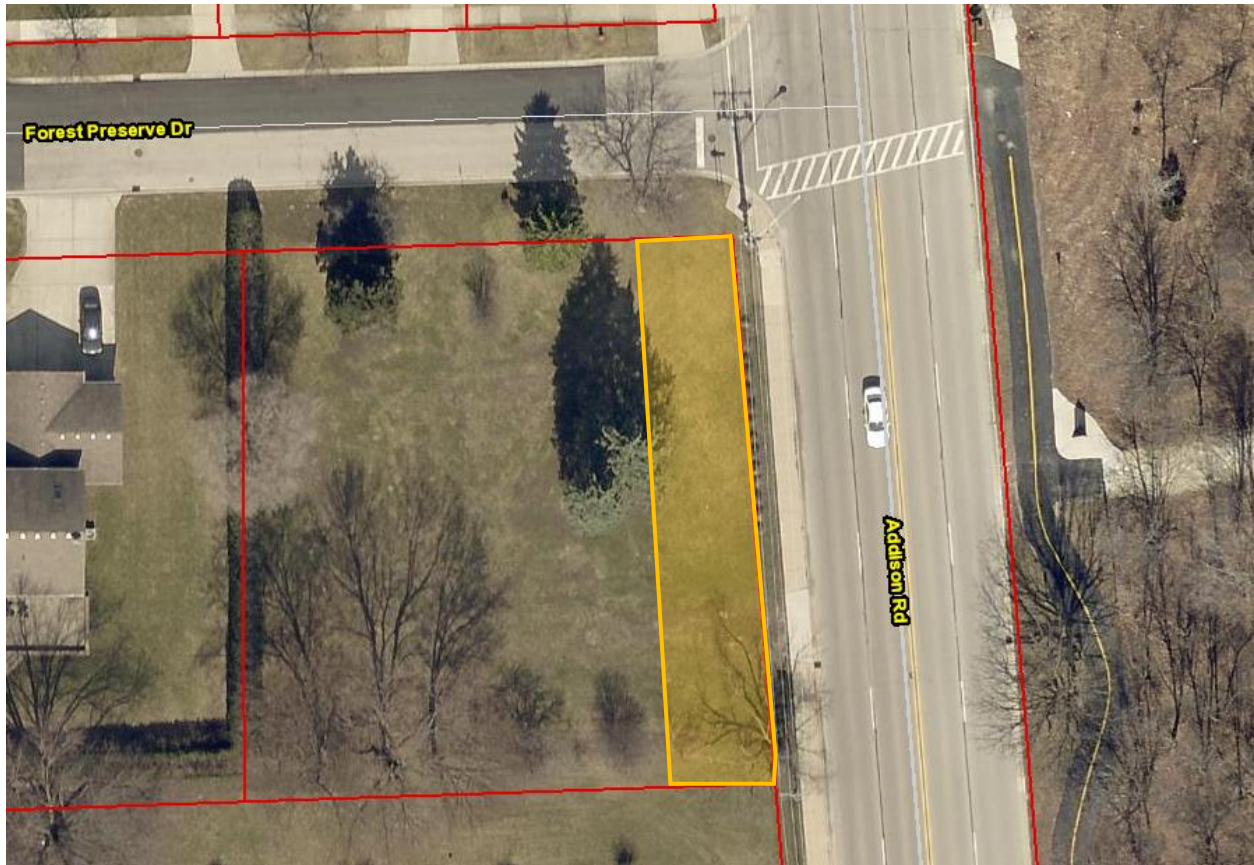
