A. Update on White Oaks Park Project

Mr. Ellmann reported that when the buckthorn removal and wetland mitigation plan proceeds, a significant amount of ground cover will have to be removed, leaving neighboring residents with views through the middle of the park. The Park District is concerned this may be upsetting to residents who are used to seeing dense foliage. To address this, the Park District is planning an education campaign for the neighbors which will explain what to expect from the mitigation plan and why it's important to remove the ground cover.
