



ORDINANCE NO. O-18-004

AN ORDINANCE AMENDING CHAPTER 2; ARTICLE VIII, SECTION 2.801 OF THE CITY OF WOOD DALE MUNICIPAL CODE CONCERNING THE APPOINTMENT OF CITY OFFICERS AND EMPLOYEES

WHEREAS, the City of Wood Dale is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

WHEREAS, the City of Wood Dale is authorized and empowered, under the Municipal Code and the Code of Ordinances of the City of Wood Dale, to regulate properties located within the municipal boundaries of the City; and

WHEREAS, in seeking to ensure full compliance with State law, to provide clarity to the Code, to resolve conflicting Code provisions and address operational concerns, the City, by and through its Staff, proposes certain amendments to Chapter 2, Article VIII, Section 2.801 of the City of Wood Dale Municipal Code; and

WHEREAS, the City Council of the City of Wood Dale has reviewed the matter herein and has determined that the same is in the best interests of the City of Wood Dale.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DUPAGE COUNTY, ILLINOIS, as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: That Chapter 2, Article VIII, Section 2.801. Appointment, of the City Code is hereby amended as follows:

The Budget Officer, shall be the Finance Director. All references to "Budget Officer" shall mean the Finance Director.

SECTION THREE: That all ordinances or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

SECTION FOUR: That the City Clerk of the City of Wood Dale is hereby directed to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

SECTION FIVE: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
