

ORDINANCE NO. O-18-006

**AN ORDINANCE APPROVING AND CAUSING PUBLICATION OF THE OFFICIAL
2018 ZONING MAP OF THE CITY OF WOOD DALE, ILLINOIS**

WHEREAS, the City of Wood Dale is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

WHEREAS, the Illinois Municipal Code requires municipal corporate authorities, in specific instances, to annually publish a map showing the existing zoning classifications and revisions made during the preceding calendar year, and the map so published shall be the Official Zoning Map for the publishing entity; and

WHEREAS, after due consideration, the Corporate Authorities have determined it is necessary and in the best interests of the City of Wood Dale to approve and publish the new Official Zoning Map for the year 2018.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DUPAGE COUNTY, ILLINOIS, as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: That the map entitled 2018 Official Zoning Map, City of Wood Dale, Illinois attached as Exhibit A is hereby approved as the Official Zoning Map of the City of Wood Dale, Illinois pursuant to the Illinois Municipal Code, which said map reflects the correct location of the official zoning districts of the City of Wood Dale, as of the date of adoption of this Ordinance.

SECTION THREE: The City Clerk is hereby directed to publish a full-sized copy of the Official Zoning Map and to make copies available in her office for inspection and purchase by the public.

SECTION FOUR: This Ordinance shall be in full force and effect from and after

its passage, approval, and publication in the manner provided by law.
