



ORDINANCE NO. O-18-008

AN ORDINANCE AMENDING THE CITY OF WOOD DALE ORDINANCE CHAPTER 15, ARTICLE XIII, SECTION 15.1324 OF THE CITY CODE REGARDING PARKING RESTRICTIONS FOR CERTAIN VEHICLES PARKING IN A MUNICIPAL PARKING LOT

**WHEREAS**, the City of Wood Dale is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

**WHEREAS**, the City of Wood Dale is authorized and empowered, under Section 11-80-2 of the Municipal Code, 65 ILCS 11-80-2, to regulate the use of streets and public parking thereon; and

**WHEREAS**, the City currently has an ordinance regarding parking in the City owned commuter parking lot; and

**WHEREAS**, the City has determined that the intent for providing a parking lot for at the train station is to benefit commuters; and

**WHEREAS**, the City has determined that the parking lot should not be used for the long term storage of certain vehicles, specifically recreational vehicles, motorhomes, boats, trailers, work trucks or any other motorized equipment.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DUPAGE COUNTY, ILLINOIS**, as follows:

**SECTION ONE:** That the recitals set forth above are incorporated herein and made a part hereof.

**SECTION TWO:** That the Code of Ordinances of the City Chapter 15, Article XIII, Section 15.1324 entitled, "Parking in Municipal Parking Lots" shall be amended as follows:

**Sec. 15.1324. Parking In Municipal Parking Lots.**

In any municipally owned and metered parking lot, it shall be unlawful for any person:

A. To park a vehicle in any area of such lot which is not designated (by lines or markings painted or placed on the pavement, wheel stops, etc.) as a parking space and/or which space has no parking meter adjacent thereto for the use thereof.

B. To back a vehicle into any parking space thereof whenever signs have been placed in such lot which shall read: "Park Facing Meter - Do Not Back In" or "Park Facing Bumper - Do Not Back In".

C. To park any motor vehicle in the city parking lot at the stalls reserved for the police department or at the stalls reserved for authorized personnel only.

D. To park or store any recreational vehicle, motorhome, boat, trailer or any motorized equipment.

E. To park or store any truck or commercial vehicle in excess of 8,000 lbs by registered weight, actual weight, GCWR or GVWR, as defined in the Illinois Compiled Statutes.

F. To park or store overnight any recreational vehicle, motorhome, boat, trailer or any commercial vehicle, motorized equipment or any other truck or commercial vehicle in excess of 8,000 lbs by registered weight, actual weight, GCWR or GVWR, as defined in the Illinois Compiled Statutes.

**SECTION THREE:** That all ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

**SECTION FOUR:** The City Clerk is hereby directed to publish this Ordinance in the manner provided for in Section 65 ILCS 5/5-2-1 *et seq.*

**SECTION FIVE:** This Ordinance shall be in full force and effect upon its passage and approval as required by law.
