



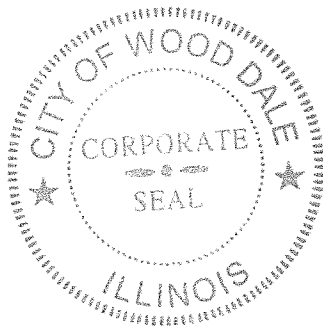

ORDINANCE NO. O-18-039

AN ORDINANCE AMENDING CHAPTER 8, ARTICLE IV, SECTION 8.403, OF THE CITY OF WOOD DALE MUNICIPAL CODE, CONCERNING THE IMPOSITION OF TAX UPON ELECTRIC SUPPLIERS

WHEREAS, the City of Wood Dale is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

WHEREAS, the City of Wood Dale is authorized and empowered, under the Municipal Code and the Code of Ordinances of the City of Wood Dale, to regulate properties located within the municipal boundaries of the City; and

WHEREAS, the Illinois Municipal Code, 65 ILCS 8-11-2(f) authorizes a municipality, like the City, that imposes taxes upon public utilities or upon the privilege of using or consuming electricity, and whose territory includes part of another unit of local government or school district, by ordinance, to exempt the other units of government or school districts from those Municipal Utility Taxes for electricity.

WHEREAS, the City has undertaken an analysis of the revenues generated from the units of local government and school districts within the jurisdiction of the City, relative to the Municipal Utility Taxes collected therefrom in connection with the use of electricity; and

WHEREAS, the City has determined that, in an attempt to work cooperatively with the other local taxing bodies within the City's boundaries, in an attempt to ease the burden ultimately on the taxpayers within the City, to consider exempting these units of local governments and school districts from the Municipal Utility Tax for electricity; and

WHEREAS, in seeking to exempt local units of government from the public utility tax on the privilege of using or consuming electricity by amending Chapter 8, Article IV, Section 8.403 of the City of Wood Dale Municipal Code to allow for said exemption; and

WHEREAS, the City Council of the City of Wood Dale has reviewed the matter herein and has determined that the same is in the best interests of the City of Wood

Dale.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DUPAGE COUNTY, ILLINOIS, as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: That Chapter 8, Article IV, Section 8.403. Tax Imposed Upon Supplying Electricity, of the City Code is hereby amended as follows:

D. Any local public entity within the jurisdiction of the City shall be exempted from the City's Municipal Utility Tax imposed upon the privilege of using or consuming electricity. For purposes of this Section, the local public entities so exempt only include: Grade School District 7, the City of Wood Dale, the Wood Dale Fire Protection District No. 1, the Wood Dale Public Library and the Wood Dale Park District. Said exemption shall remain in full force and effect from the date of passage, along with the requisite notices and shall remain in full force and effect unless and until the exemption is rescinded by the City. The decision to rescind said exemption shall be determined exclusively by the City.

SECTION THREE: That all ordinances or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

SECTION FOUR: That the City Clerk of the City of Wood Dale is hereby directed to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

SECTION FIVE: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
