

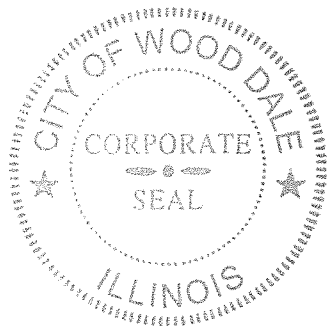

ORDINANCE NO. O-18-041

AN ORDINANCE AMENDING DEFINITIONS AND CONTRACTOR REGISTRATION REQUIREMENTS SET FORTH IN THE COMMERCIAL OCCUPANCY AND ACTIVITY REGULATIONS, CHAPTER 4 OF THE CITY OF WOOD DALE MUNICIPAL CODE

WHEREAS, the City of Wood Dale (the "City") is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*; and

WHEREAS, the City is authorized and empowered, under the Illinois Municipal Code, 65 ILCS 5/11-42 *et seq.* and the Code of Ordinances of the City of Wood Dale (the "Code"), to license, tax and regulate businesses and commercial establishments located within the municipal boundaries of the City; and

WHEREAS, pursuant to its authority, the City of Wood Dale has adopted Chapter 4 of the Code, which sets forth provisions regarding the licensing and regulation of commercial activity in the City; and

WHEREAS, upon a City Code review, City Staff has provided recommended amendments to regulations in Chapter 4 concerning definitions and contractor registration for ease of use and administration and to provide clarification; and

WHEREAS, the City Council of the City of Wood Dale has reviewed amendments recommended by City Staff and has determined that the recommended amendments are in the best interests of the City of Wood Dale.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DUPAGE COUNTY, ILLINOIS, as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: That Chapter 4, Article I, Section 4.106, entitled "Definitions" is

hereby amended as follows:

1. Add "Freight: As defined in Sec. 17.103.C."
2. Revise Transporter to read, "Any person engaging in the business of transporting freight. This term includes, but is not limited to, any person whose business is trucking goods, including freight dispatch services (as defined in Sec. 17.103.C); a truck driver who delivers containers to and from the airport, seaport or rail yard; any person that transports goods on regular routes at set rates; or any person engaged in the business of transporting parcels or other movable property."

SECTION THREE: That Chapter 4, Article V, Section 4.505, entitled "Contractor Registration" is hereby amended as follows:

1. Revise Sec. 4.505.A to read, "Registration Required: It shall be unlawful for any person to engage in the business of a general contractor, HVAC, plumbing, roofing, electrician and/or other building trades contractor within the City of Wood Dale unless or until the contractor registers with the City and pays the required registration fee. This registration requirement does not exempt or waive any other applications or fees required by this chapter or this Code."
2. Revise Sec. 4.505.B.1 to read, "Name of the registrant contractor and the owner of the company; and"
3. Revise Sec. 4.505.B.2 to read, "Business address of the registrant contractor; and"

SECTION FOUR: That all ordinances or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

SECTION FIVE: That the City Clerk of the City of Wood Dale is hereby directed to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

SECTION SIX: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
