	В	For issuance to a brewpub for the sale of beer manufactured and stored on the licensed premises for consumption on premises and in packages for consumption off premises. The Class B license holder must already possess an accompanying liquor license to sell and serve alcoholic liquor, and only the kinds of liquor (i.e., beer, wine or all alcoholic liquors) authorized under the accompanying license may be served or sold with the Class B license. Alcoholic liquors authorized for sale for consumption on premises under the Class B and accompanying liquor license may be sold, served, and consumed at a bar and/or at tables with or without a meal, provided that no alcoholic liquors may be sold or served for consumption on premises when meals for consumption on premises are not offered for sale or served.	\$2,500.00	\$1,500.00

M-R	Authorizing the sale of beer and wine for consumption only on the premises where sold and only with meals. P	Authorizing the licensee to sell and offer for sale through the internet and delivery, at retail sale, exclusively for delivery off-premises of alcoholic beverages, as defined in the Liquor Control Act of 1934, to be sold and delivered in its original package for delivery and consumption off-premises from the licensee's location where the alcoholic beverages are sold. On-premises consumption of alcoholic beverages may occur in accordance with 235 ILCS 5/6-31.	\$5,000.00	\$1,500.00
R	Authorizing the licensee to sell or offer for sale at retail alcoholic liquor on the premises where sold and only with meals.	\$2,500.00	\$1,500.00
RVG	Authorizing the licensee to sell and offer for retail sale alcoholic beverages, as defined in the Liquor Control Act of 1934, to be sold and consumed on premise from the Licensee's location where the alcoholic beverages are sold, at which licensed location video gaming shall be permitted, as provided for in the Video Gaming Act, provided the Licensee operates a full service restaurant with professional commercial kitchen equipment and appliances, in addition to a microwave oven, with a full service menu, excluding the service of primarily pre-prepared meals.	\$2,500.00	\$1,500.00
