ORDINANCE NO. 0-21-023

AN ORDINANCE AMENDING CHAPTER 14, SECTION 14.518 & 14.519, OF THE CODE OF ORDINANCES OF THE CITY OF WOOD DALE REGARDING PUBLIC INDECENCY AND PROFAMITY

WHEREAS, the City of Wood Dale (hereinafter referred to as "City") is a body politic and corporate, organized and existing pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and

WHEREAS, the City is authorized and empowered, under the Illinois Municipal Code, 65 ILCS 5/11-5-3 to regulate for the public conduct; and

WHEREAS, the City is authorized, pursuant to its police power, 65 ILCS 5/11-1-1, to carry out the powers delegated to it under its grants of authority; and

WHEREAS, the City has determined that it is reasonable and necessary, pursuant to its community caretaking function and in furtherance of public safety, to provide restrictions on certain public conduct in concurrence with the Illinois Compiled Statutes; and

WHEREAS, the City has determined that certain portions of the City Code that were codified in 1976 are in need of updating.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DUPAGE COUNTY, ILLINOIS, as follows:

SECTION ONE: That the recitals set forth above are incorporated herein and made a part hereof.

SECTION TWO: That Chapter 14, Section 14.518 & 14.519, of the City of Wood Dale Municipal Code is hereby amended in its entirety as follows:

Section 14.518. Public Indecency.

A. Any person of the age of 17 years and upwards who performs any of the following acts in a public place commits a public indecency:

- 1. An act of sexual penetration or sexual conduct; or
- 2. A lewd exposure of the body done with intent to arouse or to satisfy the sexual desire of the person.

Breast-feeding of infants is not an act of public indecency.

B. "Public place" for purposes of this Section means any place where the conduct may reasonably be expected to be viewed by others.

Section 14.519. Profanity.

This section is repealed.

SECTION THREE: That all portions of Section 14.518 & 14.519 of Chapter 14 not amended by this Ordinance shall remain in full force and effect.

SECTION FOUR: That the City Clerk of the City of Wood Dale be and is directed hereby to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

SECTION FIVE: Any and all policies, resolutions or ordinances in conflict with the provisions of this ordinance shall be, and they are hereby, repealed.

SECTION SIX: That this Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
