SUBJECT: Planters

OVERVIEW

The Streetscape & Economic Enhancement Committee has been tasked in identifying desirable locations for placement of large street planters in the City of Wood Dale. The discussion will include the preferred type/shape of the planters as well as the locations.

BACKGROUND

Many surrounding municipalities utilize large sized street planters to enhance the streetscape appeal. An example is the Village Circle in Elmwood Park which contains urn shaped planters located in the median of a street. These consists of two different size/shape planters in either black of white color, as displayed in the images below.







Shape/size of Planters

The Streetscape Committee is asked to identify the desired shape of the planters; specific color suggestions, material specifications.

Staff has identified few suppliers of street planters which will be reviewed during the meeting, but items for consideration include:

Shape:

- Rectangular/square

- Round

- Tapered/Urn

Material:

- Composite

- Concrete

- Wood

Metal

Colors:

- Gray
- Beige
- Black
- Multi-color

<u>Features</u>

- Self-watering

Locations

When identifying the desired locations for installation of the planters, the Streetscape Committee is asked to consider factors such as visibility for the public, sufficient space which would not impact pedestrian circulation, maintenance/cleaning, and ease of access by the Public Works employees for watering.

Staff would recommend considering placement of planters near the City Hall, both in front of the building facing Wood Dale Road, as well in the rear by the parking. In the future,

additional areas may be identified throughout the City, where same size/shape of planters could be added for continuity.

RECOMMENDATION

Before specific recommendation is formulated, staff would like to seek guidance from the Streetscape and Economic Enhancement Committee on the following:

- 1. Which shape or style of planter should be utilized for the City of Wood Dale?
- 2. What are the desired locations for installation of street planters?
- 3. How many planters should be acquired?
