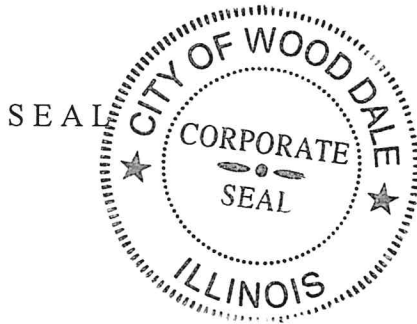

ORDINANCE NO. O-21-032

**AN ORDINANCE DECLARING PROPERTY OWNED BY THE CITY OF WOOD DALE
SURPLUS FOR THE PURPOSE OF SELLING**

WHEREAS, in the opinion of at least a simple majority of the corporate authorities of the City of Wood Dale, it is no longer necessary or useful to or for the best interest of the City of Wood Dale, to retain ownership of the personal property hereinafter described; and

WHEREAS, it has been determined by the City Council of the City of Wood Dale to sell said personal property via the internet "Public Auction" website beginning after November 18, 2021; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WOOD DALE, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION ONE: That pursuant to 65 ILCS 5/11-76-4 of the Illinois Municipal Code, the City Council of the City of Wood Dale finds that the following described personal property:

now owned by the City of Wood Dale, is no longer necessary or useful to the City of Wood Dale and the best interests of the City will be served by its sale.

SECTION TWO: Pursuant to said 65 ILCS 5/11-76-4, the City Manager is hereby authorized and directed to sell the aforementioned personal property now owned by the City of Wood Dale via the internet "Public Auction" website to the highest bidder on said property.

SECTION THREE: That all Ordinances and Resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

SECTION FOUR: No bid which is less than the minimum price set forth in the list of property to be sold shall be accepted except as authorized by the City Manager or his agent.

SECTION FIVE: That the City Clerk of the City of Wood Dale be and is directed hereby to publish this Ordinance in pamphlet form, pursuant to the statutes of the State of Illinois.

SECTION SIX: That the City Manager is hereby authorized and may direct "Public Surplus" to enter into agreement for the sale of said personal property. They will charge an administrative fee of 7% which will come out of the proceeds from the sale.

SECTION SEVEN: Upon payment of full auction price, the City Manager is hereby authorized and directed to convey the aforesaid personal property to the successful bidder.

SECTION EIGHT: That this Ordinance shall be in full force and effect from and after its passage, by a simple majority vote of the corporate authorities, and approval in the manner provided by law.

2017 Ford AWD Police Interceptor SUV

This car was purchased on 08/03/2017 by the PD and put in-service as Car #404-177. The car was in-service until 10/08/21 when it was replaced by a new car. The PD has no further use of the car and it needs to be sold on Public Surplus. The City paid \$27,224.00 for the car and has spent another \$6,110.29 and 156.50 man hours repairing this vehicle. It has a Vehicle Evaluation score of 37 out of a possible 60 points (62%).

Other than the "Change Oil" light being on the car has no known mechanical issues. There are a couple of small dings in the left and right rear doors. The interior is in fair to good shape, with the driver's seat having some small areas where the fabric is worn. The armrest on the driver's door is split. The cargo area has two cutouts in the plastic trim where the prisoner shield supports went through. Also, it is missing one of the cargo area floor panels.

This truck was purchased on 09/09/2009 for use by the Assistant Public Works Director at the North Plant. The truck was just recently taken out of service by the Wastewater Division and replaced the Car #460-176.

The City originally purchased the truck for \$24,034.75 and has spent \$7,487.81 (31% of the original purchase price) and 188.00 man hours repairing the vehicle. It has a Vehicle Evaluation score of 32 out of a possible 60 points (53%). It has no known mechanical issues. The interior is in good shape. The body has rust around the inside of the driver's door opening and on both rear quarter panels.

2008 Ford F-450 Cab & Chassis with a Reading Classic II Utility Body

This truck was purchased on 06/26/2008 for use by the Wastewater Division. It was replaced by the Wastewater Division in 2018 and was supposed to be sold, but the Utilities had meter replacement program going on and needed another vehicle. So this truck was transferred to them on 06/14/18 for use until the end of the year and their project was done. That was three years ago and the truck is still in service with them.

The City originally purchased the truck for \$40,895.00 and has spent \$33,322.62 (81% of the original purchase price) and 420.25 man hours repairing the vehicle. It has a Vehicle Evaluation score of 14 out of a possible 60 points (23%). The truck has no known mechanical issues at this time. This truck has a 6.4L diesel engine which has a history of EGR and DPF filter issues. It has been in 2 major front-end collisions with repairs totaling \$6,663.51 for one and \$7,025.56 for the other one. The body is experiencing significant rust as well as significant wear-and-tear on the interior.
