REPORT & RECOMMENDATION

REVIEW OF SECTION 6.303.A.1 OF THE MUNICIPAL CODE OF THE CITY OF WOOD DALE
RELATING TO STORAGE OF REFUSE CONTAINERS

DISCUSSION:

Chief Vesta reviewed that the Police Dept. has received several complaints regarding the storage of refuse containers since they took on the duties of Property Maintenance Inspections in 2019. The current Ordinance was written prior to having garbage totes. To improve consistency in enforcing, some options were presented to consider.

1. Make no changes.
2. Revise the ordinance to reflect that no more than 2 official City totes can be visible to the street and no additional garbage visible.
3. Change ordinance to prohibit totes being visible from the street.

There was discussion about what is currently legal and illegal, how seniors could be affected, problems for enforcement, being a "Good Neighbor", esthetic views for beautifying the City, and clarifying the current language of the Ordinance to improve consistency.

VOTE:

Ald. Messina made a motion, seconded by Ald. Sorrentino, to approve Option 2 to Revise the Ordinance Section 6.303.A.1 of the Municipal Code of the City of Wood Dale Relating to Storage of Refuse Containers. A roll call vote was taken, with the following results:

REPORT & RECOMMENDATION

AN AMENDMENT TO SECTION 15.1319 OF THE MUNICIPAL CODE OF THE CITY OF WOOD DALE RELATING TO CERTAIN POST MERIDIAN PARKING AND SECTION 15.1303 RELATING TO PARKING IN A PROHIBITED PLACE

DISCUSSION:

Chief Vesta explained requests have been received to review these ordinances to allow for some type of overnight residential parking permit and to ease restrictions at night for vehicle parking extending over a sidewalk. Chief Vesta reviewed the reasons for both ordinances and suggestions to modify the ordinances for consistency such as implementing a permit system and to only allow parking over the sidewalk during a specific time when less pedestrians are present.

VOTE:

It was decided to separate the two Codes to vote.

Ald. Woods made a motion, seconded by Ald. Ames, to Amend Section 15.1303 Regarding Parking in a Prohibited Place, to approve parking over the sidewalk 9 pm to 6 am. A roll call vote was taken, with the following results:
